The Bank has installed the following three GIFTS Software products:

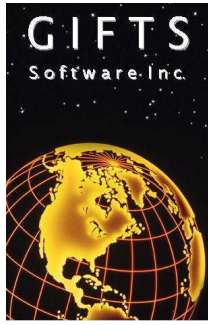
eGIFTS - **enhanced Global Integrated Funds transfer & Telecommunications System**, is an exciting next generation browser based system designed to automate the Payment (Fed, CHIPS, ACH) and SWIFT message processing of a bank. **eGIFTS** supports an advanced integrated fuzzy logic OFAC/SDN filter allowing the Bank to adjust the degree of misspelling against OFAC entities for both payments and SWIFT messages. An exclude rule feature helps to reduce false positives for known "good guys".

eGIFTS utilizes the latest hardware and software technologies and uses the powerful Oracle 11g Database to support both local and remote hot backup. The system is hardware independent and is currently running on several platforms; Intel/AMD Windows 2003 Server, IBM PSeries & i5 Servers under AIX O/S and Sun Solaris. Standardized interfaces for many popular core banking systems are also supported.

GIFTSWEB EDD – **GIFTSWEB Enhanced Due Diligence System** is a powerful Anti-Money Laundering System designed to meet BSA/AML compliance requirements as dictated by the USA Patriot Act. The product is also installed in many other countries and has been designed to meet local compliance & regulatory reporting requirements. The bank will install the following three modules:

Subpoena/Inquiry Module – allows the user to perform real-time inquiries against a database of transactions to respond to regulators, subpoenas or internal inquiries.

Profiler Module – provides AML, terrorist financing & fraud detection scenarios developed over the past eight years. It also provides the ability to filter transactional or customer data against any number of lists including PEPs, 314A, OFAC/SDN List, Local Country Sanction Lists, FSA, and NCCTs.
